Research Boundaries, Criteria, Level of Analysis

Amazon region

Amazônia Legal, also known as Brazil's Legal Amazon, is the largest socio-geographic division in Brazil and covers nine states in the Amazon Basin. The Government designated this region in 1948 based on its studies on how to plan the economic and social development of the Amazon region.

Global Governance on climate to the region

Policymaking within the regime created by the United Nations Framework Convention on Climate Change (UNFCCC), EU policymaking and delivery apparatus. Europeans states (e.g. Norway, France and UK) and non-state actors, from market player to NGOs to municipalities, all of whom have a crucial role to play in the Brazilian Amazon region.

German Climate Foreign policy

Including German government institutions, such as the Federal Ministry of Economic Cooperation and Development (BMZ), the Federal Ministry for Economy and Climate Action (BMWK), the Federal Foreign Office and the International Climate Initiative (IKI).

A few things to have in mind

- Reason / why / what the counterpart needs: How to convince the counterpart to be part?
- What the counterpart can offer: financial resources, time, knowledge etc?
- **Listening tools:** Implementing proactive listening tools
- **Partners:** Who really represent the people you are working with and to? The federal government, state, municipality, local leaders, multiple
- **Tools**: How the performances will be carried out in terms of tools?
- **Target Audience**: What is the target of the actions? What is the social group are they civil Society, business professionals, politicians etc
- **Risk Mitigation:** To avoid and deal with challenges in the implementation of your agenda and tools
- **Learning loop**: How can the process can be adjusted over time?
